## Minutes of the EUROPA CUP meeting 18<sup>th</sup> of February 2006 at 10:00 AM in MÜNICH (GER)

- The chairman Stein WILLERSRUD welcomed the participating members and gave apologies for absence. He puts forward that Mr. GRILL Wilhelm had organised the meeting held on the MÜNICH Olympic range and that his presence would permit a coordinated approach within the ESC structures.

### **1. Short discussion about the 2005 events :**

- M. GRILL spoke of the European Championships in BELGRADE and put forward the organization of these championships.
- Konrad JÄGGI and Roger CHASSAT described the good organization of the different matches of the circuit of the Europa Cup at which they were present.

**2. Events 2006. Is the timetable 2006 correct ?**

- For EC PLZEN, EC THUN, the World championships in ZAGREB and the final of the europa cup in WINTHERTUR the dates will remain unchanged (see appendix).
- For AARHUS the dates of organization have been changed. The committee put forward the fact that the new dates are too close to the end of the World Championships, and in this way the Danish organization risks of having less shooters. But the committee accepted this change of date.

**3. EC rules :**

- Willi recalled that the committee of the EUROPA CUP is a SUB-COMMITTEE of the Rifle Committee (European Shooting Confederation), and because of this the President Mrs. Unni NICOLAYSEN would like that the committee works in harmony with the regulation of the ESC.
  - After discussion between all those present, the committee accepted to work in accordance with the ESC, and therefore agreed to remove the last sentence of the point 6.1 (At the committee first meeting they all propose their choice of vice-chairman and secretary) of the EUROPA CUP rules.
- Konrad JÄGGI proposed a change of the rules for the point 3.2. He suggests to remove for the women " 8 shooters are classified" and to keep "3 nations participate".
  - After discussion the committee accepted the change in rules in order to enhance the promotion of the women in some countries.
- Other points raised by KONRAD, "If the American shooters come to the EC in THUN, can we make only one ranking?"
  - After discussion the committee put forward the point of rules 3.6 :“Non european shooters are considered non-competitive for the allocation of points, but are ranked normally otherwise in the list of results.” But in order to promote the 300 m by the federations and journalists, the committee suggested that there are two rankings: -ranking EUROPA CUP and -ranking OPEN EUROPA CUP.
  - ATTENTION the rules must be changed for this reason.  
For the future, a revision of the point 3.6 will be discussed at the time of the final of the EUROPA CUP in WINTERTHUR.



- On the other hand, the committee decided that this year we will not give out other invitations for the non - Europeans to the Final as shown in article 8.4.

#### 4. **Representative from EC Committee in the different EC.**

- Roger CHASSAT took advantage of the presence of a representative of the ESC to ask a question:  
Stating that the committee of the EUROPA CUP is a SUB - COMMITTEE of the ESC, why then is the Chairman of this committee is not invited to the big championships?
  - Willi GRILL replied that at the time of an invitation for the big championships the EC chairman's national federation must pay normally for the travel, and that it is the organizing country that would then look after him/her.
  - Willi GRILL is going to inquire in order to regularize the position of the Chairman of the committee of the EUROPA CUP.
- Willi GRILL asked us to increase the profile level of the competitions of the EC circuit by the presence of "B" level referees.
  - Roger CHASSAT proposed to come with a referee of level minimum B on the competitions of the EC circuit to defray the cost of the French Federation for this year.

“This committee is a sub-committee of the ESC, and is composed of a chairman and maximum of four committee members, Willi GRILL is selected by the ESC Presidium and the rifle committee.”

- After discussion the committee decides to take the decision of the renewal at the meeting during the EC Final of WINTERTHUR.

### **6. Other questions about the Europa Cup 300 m.**

- Roger CHASSAT asks for a discussion on the “big trophies” of the EC Final, those are huge in size, and raise problems of transportation, especially by plane. He estimates that they are too big and that the shooters do not have a retort.
  - Why don't we give a trophy made of crystal as in Saint Jean de Marsacq, the shooter would be able to bring it back easily and keep it at home?
- After discussion and after have verification the part of rule 9.2, it is decided that during the final of Europa Cup in Winterthur the trophies will be distributed to the promoters cities, that means to say:
  - the trophy of the 3X40 for GENEVA
  - the trophy of the 3X20 for LIESTAL
  - the trophy of the 60 PRONE for SAINT JEAN DE MARSACQin order to thank them for their organization.  
A letter will be sent to their national federation in order to bring them the trophy.
- From WINTERTHUR a trophy will be given every year to the five winners. This trophy will be in crystal with in incirtion of the promoter country and the logo of the EUROPA CUP, as in St Jean de Marsacq.  
The trophies will be paid from the monies taken during the Europa cup. The sum of ten euros per shooter and per event will not change.

Having completed the agenda, the chairman Stein WILLERSRUD thanked the members for their work and closed the meeting at 17h15.

# ANNEXE

## The modifications EC 300m rules :

### 3. TECHNICAL BASIS

#### 3.2 Allocation of Points

All these Europa Cup, providing, for men, at least 5 nations participate, and 15 shooters are classified, for women 3 nations participate ~~and 8 shooters are classified~~, allot points in relation to the place and the result obtained by the shooter and in accordance with a pre-determined scale.

### 6. ORGANIZING COMMITTEE

#### 6.1 Definition

- All decisions on activities and organisation of the Europa Cup will be taken by the elected committee. These decisions should be unanimous, or by a majority vote should that be deemed necessary.
- This committee is a sub-committee of ESC and is composed of a Chairman, maximum of 4 committee members, one of which will be selected by the rifle committee ESC.
- The committee will be elected for four years at a meeting during the Europa Cup final
- ~~At the committee first meeting they all propose their choice of vice-chairman and secretary.~~
