Dear Colleagues,

At the request of the European Commission (EC), the European Chemicals Agency (ECHA) has prepared a proposal for a restriction of the use of lead in ammunition for hunting, outdoor sports and in fishing. Along with the ISSF, many of you contributed with comments during 2021 when the consultation period was open for the restriction report. ECHA received 319 comments during this consultation.

As announced in January 2022, the two subcommittees of ECHA - the Committee on Risk Assessment (RAC) and the Committee for Socio-Economic Analysis (SEAC) – published their opinions on the 29th of June, 2022. From the restriction, RAC addresses human health and environmental issues and SEAC analyses socio-economic impacts. During the committee's opinion making process it is possible to submit comments. Please observe that the final deadline for these comments is **23:59 Helsinki time** (**EET**) on the **29**th of August, **2022**. It is also possible to supply information to specific questions regarding sports shooting and steel gunshot and also lead gunshot recovery (other questions also for hunting and fishing).

Consultations help to provide information and are needed for necessary updates to the proposal. It is important that we share our expert knowledge for consideration. After this consultation period, the committees' opinions are currently expected to be ready at the end of 2022. After this step they will be sent to the EC for the final decisions. If you haven't done so already, we encourage you to read through the opinions, the background documents and even the responses made to the comments of the restriction report. Please then send your comments to ECHA about the proposal before the consultation ends (29/08/2022). Please note that you may participate as an individual or organization and even if you are outside the EU.
